The Safeguarding Children Arrangements in Hillingdon

Based on the principles set out in **Working Together to Safeguard Children** (2018)

The ultimate forum responsible for the safeguarding of Children and Adults in Hillingdon is the **Executive Leadership Group** (ELG).

This group provides governance, leadership, oversight and challenge to both adults and children's Boards.

The ELG consists of

- Local Authority's Chief Executive,
- Chief Nurse of Hillingdon NHS Clinical Commissioning Group
- Metropolitan Police Service Borough Commander.

This group has joint and equal responsibility for safeguarding in Hillingdon

Safeguarding Children Partnership Board

The main engine of the safeguarding arrangements for children is the Safeguarding Children Partnership Board.

To reflect the vision of joint and equal responsibility the Board is chaired on a yearly rotating basis by a representative of the three statutory partners (*Police, ICB and LA*)

Currently the chair is a representative of the Metropolitan Police Service:
