ADMISSION APPEALS PANEL

Composition of Admission Appeals Panel

The appeal panels must have a minimum of three members at all times to hear the appeals and must consist of:

- at least one lay member. Lay members are people without personal experience in the management or provision of education in any school (though it is permissible to use people who have experience as governors of other schools, or who have been involved in education in any other voluntary capacity); and
- at least one person with experience in education, who is acquainted with educational conditions in the area, or who is the parent of a registered pupil at a school.

DISQUALIFICATION FROM MEMBERSHIP OF ADMISSION APPEALS PANEL

The following persons are **<u>not</u>** eligible to serve as a member of Admission Appeals Panel:

- a) any member of the local authority which is making the arrangements or which maintains the school in question;
- b) any member or former member of the governing body of the school in question;
- c) any person employed by the local authority in a capacity connected with education, or the governing body of the school in question, other than a person employed as a teacher or as a teaching assistant;
- d) any person who has, or at any time has had, any connection with the authority or the school, or with any person within sub-paragraph c), of a kind which might reasonably be taken to raise doubts about his ability to act impartially in relation to the authority or the school; or
- e) any person who does not satisfy the training requirements as set out in the Appeals Regulations.

EXCLUSION APPEALS PANEL

Composition of Exclusion Appeals Panel

The LA must constitute the appeal panel and appoint a clerk.

Each panel must consist of (1 lay (Chair), 1 governor and 1 headteacher)

Chair

Must be a lay member, defined as someone who has not worked in a school in any paid capacity, although they may be (or have been) a school governor or work (or have worked) in a school as a volunteer. The chair could, but need not be, someone with a legal qualification.

Governor

Must be, or have been, a governor of a maintained school or a member of a management committee of a Pupil Referral Unit, provided they have served in this capacity for at least 12 consecutive months in the last 6 years (but must not be or have been in the last 5 years, a teacher, head teacher or teacher in charge of a Pupil Referral Unit).

Headteacher

Must be or have been within the last 5 years, a head teacher of a maintained school or a teacher in charge of a Pupil Referral Unit. If the exclusion is from a Pupil Referral Unit then this representative can be either a head teacher of a maintained school, or a teacher in charge of a Pupil Referral Unit.

DISQUALIFICATION FROM MEMBERSHIP OF EXCLUSION APPEALS PANEL

A person may **not** serve as a member of a review panel if they:

- are a member/director of the local authority/academy trust or governing board of the excluding school;
- are the head teacher of the excluding school or anyone who has held this position in the last five years;
- are an employee of the local authority/academy trust, or the governing board, of the excluding school (unless they are employed as a head teacher at another school);
- have, or at any time have had, any connection with the local authority/academy trust, school, governing board, parents or pupil, or the incident leading to the exclusion, which might reasonably be taken to raise doubts about their impartiality (though an individual must not be taken to have such a connection simply because they are employed by the local authority/academy trust as a head teacher at another school); or
- have not had the required training within the last two years.

GENERAL

CONFIDENTIALITY

The confidentiality of information obtained through the appeal process must be respected.

LINKS WITH A PARTICULAR SCHOOL

You are asked to give details of any school with which you are actively involved, e.g. as a parent or as a governor. This is to ensure that we do not appoint you to a panel hearing appeal relating to that school.

FREQUENCY OF MEETINGS

The majority of appeal hearings take place in May/June/July, when there are often two or more panels each weekday. For the rest of the year there are usually three or four panels arranged each month.

The amount of time spent hearing appeals will vary – panel members could have up to three days of appeal hearings for one school over a few weeks, others may only be asked to serve occasionally for in-year appeals. Panel members are asked to indicate how much time they are willing to offer when panel dates are being arranged.

TRAINING

One day of training must have been completed before sitting on a panel.

ALLOWANCES FOR APPEALS PANEL MEMBERS

This is purely a voluntary role and no payment is made, but appeals panel members are eligible in certain cases to receive allowances for financial loss, travel and subsistence. Refreshments will be provided for panel members throughout the day. Please ensure you advise us of any dietary needs. Free car parking is available at the usual venue.
