Appeals

- All parents have the right to appeal under the School Standards & Framework Act 1998 against the refusal of a place at any of the schools for which they have applied.
- Community School appeals to be made to the local authority
- Non community school appeals to be made direct to the schools.



Fair Access Protocol

- The Fair Access Process is a statutory requirement as set out in the School Admissions Code 2021.
- Annually reviewed and agreed with majority of Headteachers
- Monthly Fair Access Panel Meetings are held to place these children into school.
- Academic year 2021-2022 - 134 Secondary referrals 2 Primary FA referrals
- **Academic year 2022- January 2023- 131 Secondary referrals**



Consultation

- The LA have consulted to reduce the PAN at Coteford Infant School from 81 to 60.
- Grange Park Infant and Nursery School have consulted to reduce the PAN from 120 to 90.
- Grange Park Junior School have consulted to reduce the PAN from 120 to 90.
- 28 February - Deadline for admission arrangements to be determined even if they have not changed from the previous year and a consultation has not been required.
- 15 March - Deadline for admission authorities to provide determined admissions arrangements to the LA and publish on website.
