Schools Capacity Survey

- Yearly statutory return due for submission to DfE by end of July
- Physical building capacity
- Planned admissions number (PAN) [mainstream only]
- Pupil number projections for each planning area
- Figures from the GLA are provisional at this time little change anticipated



Secondary

- Some short-term pressure expected as upper Primary year groups are still relatively large – we are managing this with bulge classes, as we have for several years
- Hillingdon also net imports pupils at year 7 (i.e. a higher number of non-residents entering Hillingdon schools compared to Hillingdon residents choosing out of borough schools) which increases the pressure
- In 2-3 years we will start to see the smaller year groups aging through from the primary phase which will alleviate the current pressure



Primary

- Falling demand as all of London is experiencing net outward migration and falling birth rates since 2016.
- Reception forecasts continue to decline years of lower birth rate enter school
- Some small areas of growth related to new housing developments, but generally we expect primary school rolls will continue to decline for the next few years
- Forecasts predict the birth rate is now stabilising change from the past
 2 years
- Hillingdon is working with schools to help manage large numbers of vacancies

Special

- There is a rapidly increasing demand for special places as we identify SEND pupils earlier and more frequently than in the past – similar trends are seen across the country
- We have multiple ongoing projects to increase our provision for SEND pupils in borough, including expansion of some existing provisions, new resourced provision and SEN units in our mainstream schools, and new special school builds coordinated with the DfE

- Marketing a review in the marketing strategies / advice needed
- Budget impact on all areas of the budget / number on role has the biggest impact on budget allocation

Summary Reception Figures

- Number of Reception places available 4158
- Current actual figures from last census 3804
- Spare Reception capacity 354 places
- 10 year forecast with proposed PAN reductions 732 spare Reception places.



Conclusions

- Volatility in all areas Oversupply of Reception places, PAN reductions to continue
- Limited supply of Year 7 places, bulge classes likely to be necessary for next 2-3 years
- Constant movement in and out of the borough
- PAN reductions in Reception very likely to continue, will be reviewed yearly for specific decisions
- Secondary parental preferences for good/outstanding schools leading to excess pressure for some schools
