# School Websites – checklist for maintained schools

The following checklist summarises the information that you must publish on your website.

If your school **doesn't maintain its own website**, you **must** still publish all of the relevant information in the checklist online. You can use an alternative website to host the information, as long as you let parents know the address and details – for example, by providing parents with the URL (website address) and any other relevant details.

In addition to the requirements in the checklist, you'll also need to make the following information publicly available, which you can do by putting it up on your website:

- Child protection policy if you don't put your child protection policy on your website, you must provide a paper copy on request
- **Freedom of information publication schemes –** you must make certain information publicly available as part of the 'publication schemes' you're required to have under the Freedom of Information Act 2000
- Public sector apprenticeship target information find out how to meet this target, if applicable

# **Updates since September 2021**

# School uniform information

You are now required to publish your school's uniform policy online and you should also publish information on second-hand uniforms (e.g. where they can be bought). This is set out in the DfE's <u>statutory guidance on</u> the cost of school uniform.

### School opening hours

You should publish information about school opening and closing times, and total opening hours per week. See below for more details.

### Remote education information

You're no longer required to publish information about your school's remote learning provision. However, the DfE says you should consider doing so.

## Personal telephone number of the careers leader

You do not need to publish the careers leader's personal telephone number. Use a school number instead, for data protection reasons.

# Accessibility plan

It's not a requirement to publish your accessibility plan on your website – but, whether you do so or not, your SEN information report must mention it and confirm that it covers the required areas.
